Today, I am delighted to be able to tell you about some important changes in the governance of the Award in China.

These changes shouldn't make any difference to the high standard of service you expect to receive from the Award, but they do regularize our engagement in China and bring the Award fully in line with what's expected of us by regulators, government and officials.

We've achieved these changes with the terrific support of colleagues in London, local government in China and the excellent staff team of the Award in China that you already know.

Here's the technical detail. The Award has now transitioned from a Wholly Foreign Owned Enterprise (a WFOE) to a local enterprise. This is an exciting step forward that will enable the Award in China to best meet the needs of licensed schools and organizations, recognized providers, and ultimately benefit current and future participants.

It puts the Award in China on exactly the same footing as National Award Operators in other countries, licensed by, but not owned by, The Duke of Edinburgh's International Award Foundation in London.
